
## 23.2.2 Enhancements

### 2. Application Integrations System Environment Specification

#### Provider Search

The provider search requires that sites do not block HTTP requests to <u>https://maps.googleapis.com</u>.

#### External Authentication

The following are the steps to be completed by clients to configure External Authentication:

Receive redirect URI: Obtain redirect URI from the Care Management Implementation team.

Register client APP: Register the client APP inside the identity provider using the redirect URI.

- Note down client ID and client secret: Once the client APP is registered, the client ID and client secret will be assigned to the client APP.
- Supply identity provider info to Care Management: Provide Identity Provider endpoint information, client id, and client secret to the Care Management implementation team.
