What is EVV?

The 21st Century Cures Act mandates that states implement Electronic Visit Verification (EVV) for all Medicaid Personal Care Services (PCS) that require an in-home visit by a provider. According to the 21st Century Cures Act, specific elements of a visit must be electronically verified, including:

- Date of the service
- Location of service delivery
- Individual providing the service
- Time the service begins and ends

State by state status

WellSky Personal Care supports EVV integrations with different state aggregators such as, but not limited to: HHAExchange, Sandata, NetSmart, Authenticare. Below is a list of each state's status with EVV and WellSky Personal Care. If a state is listed as "closed," the state Medicaid program is contracted with a single vendor and mandates that all provider agencies use that vendor's system. For more information about that closed state, you will need to reach out to the vendor to understand what is required for compliance.
